Subject : Standing No Objection Certificate/ Permission in favour of Medical Officers of OMHS Cadre and Dental Surgeons of OMS (Dental) Cadre working under Health & Family Welfare Department to apply for the post of Assistant Professor (Broad Specialty) and Assistant Professor (Super Specialty) under OMES Cadre through OPSC.

A good number of applications are received throughout the year from Medical Officers of OMHS Cadre and Dental Surgeons of OMS (Dental) Cadre to accord permission/ NOC for applying/ appearing the recruitment examination for the post of Assistant Professor (Broad Specialty) and Assistant Professor (Super Specialty) under OMES cadre conducted by OPSC. Since the post of Assistant Professor under OMES Cadre is also under the administrative control of Health & Family Welfare Department, this Department grants permission / NOC to Medical Officers / Dental Surgeons to apply for the post of Assistant Professor (Broad Specialty) and Assistant Professor (Super Specialty) under OMES Cadre through OPSC in a very routine and mechanical manner killing valuable time of the Department. Further applicants are also often visiting the Department for expediting their cases. Delay in granting permission / NOC also sometimes leads to harassment of the applicant employees.

Therefore to save applicant Medical Officer/ Dental Surgeon from bothering for NOC and also Health & FW Department from such unproductive work, Government have been pleased to hereby grant a Standing Permission and No Objection Certificate in favour of regular Medical Officers of OMHS Cadre and regular Dental Surgeons of OMS (Dental) Cadre working under Health & Family Welfare Department to apply for the post of Assistant Professor (Broad Specialty) and Assistant Professor (Super Specialty) under OMES Cadre through OPSC on the following conditions:

1. The Medical Officer / Dental Surgeon shall not neglect his/her official duties/responsibilities for appearing the recruitment examination.
2. The Medical Officer / Dental Surgeon must take prior permission of the competent authority for leave and Head Quarter leaving permission for appearing in the recruitment examination and related job interview.
3. If selected, the Medical Officer / Dental Surgeon concerned will be relieved from OMHS cadre at Government level after observing all formalities. Government may refuse to relieve any Officer in public interest.

4. This 'Standing Permission/NOC' shall not be construed as permission of the Department to relieve Medical Officer/ Dental Surgeon from its administrative control. In case of selection for the post of Assistant Professor under OMES Cadre, the concerned Medical Officer/ Dental Surgeon must seek approval of this Department, through proper channel, to be relieved from his/her current service.

This order shall henceforth be treated as the **Standing Permission/NOC**, issued by the Department in favour of regular Medical Officer of OMHS Cadre / Dental Surgeon of OMS (Dental) Cadre, which can be produced by them before required Authority to apply for the post of Assistant Professor (Broad Specialty) and Assistant Professor (Super Specialty) under OMES Cadre through OPSC. No individual permission/NOC shall henceforth be required to be issued by this Department nor shall any such application henceforth be entertained by the Department.

All pending applications for grant of NOC/Permission for the said purpose in favour of the applicant Medical Officer/ Dental Surgeon individually are hereby discarded.
