**RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASSISTANT
PROFESSORS & SENIOR RESIDENTS / TUTOR IN SCB MC, CUTTACK**

Eligible candidates are invited to attend the **Walk in Interview** for the post of Assistant Professor (Broad & Super-Specialty) & Senior Resident / Tutor (Broad-Specialty) in SCB Medical College, Cuttack on **Dt. 12.11.2024** on contractual/deputation basis. The details of eligibility criteria/ vacancies/ etc are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for one year renewable for a maximum period of four years for the post of Assistant Professor subject to satisfactory performance. For the post of Senior Resident, the engagement shall be purely temporary on year to year tenure basis subject to satisfactory performance for a maximum period of three years. The regular / contractual faculties of any Govt. Medical College of the state, VIMSAR, Burla or AHPGIC Cuttack or PGIMER & Capital Hospital are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

3 ELIGIBILITY AND QUALIFICATIONS FOR SENIOR RESIDENTS / TUTORS:

- 3.1 For the post of Tutor, a candidate must possess a MBBS Degree or equivalent degree recognized by MCI/NMC from MCI/NMC permitted / approved / recognized institution or as may be notified by MCI/NMC from time to time. The candidates must have completed the compulsory one year rotating internship.
- 3.2 For the post of Tutor, candidates with Post Graduate degree in concerned subject will be preferred over the MBBS candidates. If candidates with MBBS not available Medical MSc. in concerned subject with PhD will be taken.

- 3.3 **For the post Senior Residents in Broad-specialty disciplines**, the candidate must possess MD / MS / DNB or any equivalent degree in concerned discipline applied for or as may be prescribe by OMES rules / NMC Minimum Qualifications for teachers in Medical institutions Regulations 2022 from time to time in force.
- 3.4 Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

- 3.5 One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.
- 3.6 All Qualifications as on the date of interview shall be considered.
- 3.7 Vacancy based reservation is applicable as per Govt. of Odisha, H&FW Department Resolution No. 18582/H Dt. 13.08.2020.
- 3.8 Other eligibility conditions:
- 3.8.1 The candidate must be a citizen of India.
- 3.8.2 The Medical Graduates must have registered their Medical qualification at Central / State Medical Council (Permanent Registration).
- 3.8.3 The candidate must not be continuing / have completed the tenure as SR / Tutor in any Govt Medical College of the State.
- 3.8.4 The candidate whose service as SR / Tutor has been terminated by any Govt. Medical College in the state for whatsoever reason will not be considered for reengagement.
- 3.9 Age: For SR & Tutor the age must be less than 45 years as on the date of interview.
- N.B:** The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4 ELIGIBILITY & QUALIFICATION FOR ASSISTANT PROFESSOR

- 4.1 The candidate must possess MD/MS/DNB/DM/M.Ch or equivalent degree in the concerned discipline from any MCI/NMC approved/ recognized/ permitted Medical Colleges and/or any other academic qualification with such additional teaching

experience in the subject as may be prescribed by the NMC and as per “Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022” as amended from time to time. The candidates having DM/M.Ch/DNB or equivalent degree are not required any additional teaching experience.

- 4.2 Must have registered himself/herself under any Central / State Medical Council after obtaining the degree (Permanent Registration).
- 4.3 Must have one year of Teaching Experience Certificate as SR/Tutor in the concerned subjects after completion of PG Course.
- 4.4 The above qualifications must have obtained on or before the date of interview.
- 4.5 The Selection of Asst. Professor will be strictly on the basis of merit list prepared on basis of career marks as these are purely temporary and tenure-based engagements and done only to meet the exigency. On regular recruitment of faculty by the OPSC or on completion of the contractual tenure, whichever is earlier, they shall be disengaged. Weightage for different examination shall be as under:

HSC/Matriculation-	20% of total percentage of marks secured
Intermediate/+2 Science-	20% of total percentage of marks secured
MBBS/M.Sc. examination-	60% of total percentage of marks secured
In case of candidates who have passed PG in 2016-17 and afterwards,	
MBBS/M.Sc. Examination – 30%, PG – 30%	

One mark will be deducted from the total career mark for each extra attempt taken to pass the examination.

In case of tie it will be resolved as follows:

- i. The candidate securing more mark in MBBS/M.Sc. as the case may be shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- 4.6 **AGE LIMIT:** The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

The pre-registration process to participate in the walk-in interview shall be up to **5 PM of 10.11.2024**. Eligible candidates shall appear personally before the Convenor in the venue (**College Council Hall, 2nd Floor Office of the Dean & Principal, SCB MC, Cuttack**) as per programme notified, i.e., at **10.00 AM on Dt. 12.11.2024** and submit the application form attached to this advertisement duly filled in and self-attested photocopy of required documents and two-color passport photographs. They must bring the original documents for verification. A recruitment fee of **Rs. 500/-** is to be deposited through Demand Draft in favor of the **SCB Recruitment Committee, SCB MC payable at SBI SCB MCH Campus Branch, Cuttack**. **Candidates applying for multiple disciplines should submit multiple number of application and bank draft as applied.**

Original bank draft is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of SCB Medical College, Cuttack i.e. (<https://scbmch.in/>).

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her.
