Finance Department have allowed drawal of 10% of arrear salary arising out of ORSP Rules, 2017 vide Order No.5168 dated 13.02.2020, for drawal of 30% vide Order No. 26 dated 01.01.2022 and for drawal of balance remaining arrear salary as on 31.03.2022 vide Order No.7331 dated 28.03.2022.

In view of the orders, issued by the Finance Department regarding release of balance 60% of arrear arising out of revision of pay under ORSP Rules, 2017, most of the Medical Colleges have already drawn the arrear salary of the teaching staff.

However, no such order for drawal of balance arrear pay arising out of ORSP (MCT) Rules, 2019 has been communicated to the Medical Colleges.

Keeping the above facts in view, Government have been pleased to allow drawal of 60% arrear salary of all teaching staff of all Government Medical Colleges, VIMSAR, Burla and AHPGIC, Cuttack, covered under the ORSP (MCT) Rules, 2019, w.e.f. the dates allowed by Finance Department for other Government employees covered under ORSP Rules, 2017.

This has been duly concurred in by the Finance Department in their OSWAS File No. FIN-SOS3-ESTT-0012-2019.
